- Ben Taliaferro asked the Board of Trustees to explore the feasibility of installing Wi-Fi in the Clubhouse. Mr. Taliaferro also suggested increasing “Perks” given at certain activities. He also made some suggestions regarding road and bluff maintenance.
- Brooks Solterman thanked the Board for their care of community assets. Mr. Solterman requested the clean up of the Laurel Stairway. He also commented on allergens from Cottonwood trees asking the Board to investigate the feasibility of removing the Cottonwood trees on the beach.
- Debbie Bonneau was asked some questions regarding tree grooming in beach areas.
