Introduction of new Board Members/Officers

- George Patrash informed the membership that all board members were re-elected and that all current officers retained their positions.

- A problem with the drain in the Lakeview Pine area was corrected by Mark Hayden.
- The swing set was also repaired by Mark Hayden.
- The cement bench at Pine was severely damaged and replaced by a new Victor Stanley bench.
- All of the rusted chains that protect our "Walk Downs" have been replaced with new yellow coated chains for safety.
- New officers were elected and the Executive officers remain the same.
- The Annual Children's Fun day was a success due to the incredible efforts of Lisa Doestch and her volunteers.
- Lexington Heights made a \$50 donation to the Whispering Pines Animal Sanctuary as a "thanks" for their visitations at Children's Fun Day.
- Members were reminded to visit the Lexington Heights Web Site for community information. A "thanks" was given to Gene Komaromi as Webmaster.
